Failure to complete the project within this period would automatically mean that the beneficiary would have to pay back the 50 per cent of the grant issued by NBC prior to starting date of project.
4. The project must acknowledge aid by *National Book Council's Malta Book Fund 2022* in print or virtual media, as follows:
  - i. In the case of projects falling under the **Publication Grants for New Books** category, back cover must bear the National Book Council's logo and preliminary pages must state that said publication was funded by the National Book Council's Malta Book Fund 2022: *Dil-pubblikazzjoni kienet meġġuna mill-Fond Malti tal-Ktieb 2022 tal-Kunsill Nazzjonali tal-Ktieb* for books in the Maltese language // *This publication was funded by the National Book Council's Malta Book Fund 2022* for books published into any other language.
  - ii. In the case of projects falling under the **Translation Grants** categories, when published preliminary pages must state that said translation was funded by the National Book Council's Malta Book Fund 2022 and bear the National Book Council's logo: *Dil-pubblikazzjoni kienet meġġuna mill-Fond Malti tal-Ktieb 2022 tal-Kunsill*

*Nazzjonali tal-Ktieb* for books in the Maltese language // *This publication was funded by the National Book Council's Malta Book Fund 2022* for books published into any other language.

In the case of projects falling under the **Publishing Grants for New Editions of out-of-print Works** category, back cover must bear the National Book Council's logo and preliminary pages must state that said publication was funded by the National Book Council's Malta Book Fund 2022: *Dil-pubblikazzjoni kienet meġġuna mill-Fond Malti tal-Ktieb 2022 tal-Kunsill Nazzjonali tal-Ktieb* for books published in the Maltese language // *This publication was funded by the National Book Council's Malta Book Fund 2022* for books published into any other language.
- iv. In the case of projects falling under the **Book Translation Pitch Grants** category: no logo placement requirement.
